# Egypt, China to launch \$7B agriculture complex in El Wadi El Gedid

Chinese investors, in partnership with Egypt's private and public sectors, have launched a \$7 billion investment alliance to develop a vast agricultural complex spanning 1 million acres in El Wadi El Gedid Governorate. Mohamed Alaa, Secretary-General of the Egyptian-Chinese Businessmen Association, revealed the plans to Asharq Bloomberg, noting that the project is supported by the Chinese government and funded by private Chinese companies. The initiative's first phase, set to cultivate 1,000 acres, is expected to conclude by September 2025. Egypt Today.

Findings reveal that while China's development and security discourses resonate with African policymakers, the semantic nuances and historical contexts of Chinese terms often lead to divergent interpretations.
