"I dream of becoming a doctor because I want to save lives," Nangiyo said, noting that school feeding has helped keep her and her friends in school. Choko

The Chinese oil giant China National Offshore Oil Corporation (CNOOC) in Uganda is holding a two-day medical camp in the country's western district of Kikuube, where hundreds of local residents are being provided with free medical services and treatments.
