Oil falls on easing Libya supply concerns, lingering China demand worries

Oil prices slumped over 2% on Wednesday as worries over supply disruptions in Libya eased and demand concerns continued despite China's latest stimulus plans. Still, falling crude inventories in the United States and rising tensions in the Middle East provided some support. Brent crude futures fell \$1.71, or 2.27%, to settle at \$73.46 a barrel. U.S. West Texas Intermediate crude slipped \$1.87, or 2.61%, to settle at \$69.69 per barrel. Libya's factions signed an agreement on the process for appointing central bank governor, an initial step to resolve the dispute over control of the central bank and oil revenue that has slashed Libya's oil output and exports. "A pending resolution to Libya's central bank crisis would restore significant oil supply, while U.S. Gulf production outages are seen as very temporary," said Clay Seigle, energy strategist. Reuters.
